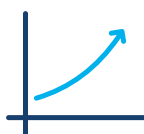

## The Promise of Lifelong Protection

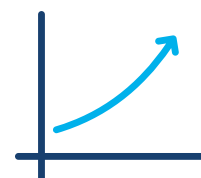

## 财富稳定增长

## Stable Wealth Accumulation



计划助您逐步建立财富，提供保证现金价值、非保证的“年终红利”及“终期红利”，让保单的现金价值<sup>2,4</sup>不断递增，为孩子未来的各项需要作好储备。

The plan offers a Guaranteed Cash Value and non-guaranteed Annual Dividend and Terminal Bonus, boosting the Cash Value<sup>2,4</sup> continuously. You can build wealth steadily so as to prepare for the future needs of your child.

**Guaranteed Cash Value** – Regardless of the economic climate, the policy will deliver a Guaranteed Cash Value.

**年终红利** – 于保单生效满3年起每年派发非保证年终红利，您可随时提取使用，又或用作缴付保费，或者将已派发的红利累积于保单内，继续获利滚存<sup>5</sup>，赚取更多回报。

**Annual Dividend** – Effective from the third policy anniversary onwards, the non-guaranteed Annual Dividend will be payable annually. You may choose to withdraw the declared dividend anytime, use it to pay your premiums, or leave it to accumulate in your policy<sup>5</sup> for further growth.

为让您更好掌握财富增值，您可于第15个保单周年日起，申请行使终期红利锁定权益，将部分终期红利所提供的回报锁定，转换为年终红利以提取使用，或于保单内滚存生息<sup>5</sup>，以争取更高收益。于保单生效期内，您可锁定高达60%的终期红利。

此外，您可透过调低保障额<sup>7</sup>以提取现金价值，而毋须扣除任何已支付的糖尿病保障赔偿金额；亦可透过保单借贷，获享高达90%保证现金价值的贷款额，助您灵活调动资金，同时让余下的现金价值继续滚存累积。

At different life stages of your child, the financial needs may vary. The flexible funding options of the plan enable you to build a brighter future for your child.

### Annual Dividend withdrawals

You may make withdrawals or leave it to accumulate<sup>5</sup> in the policy.

### Terminal Bonus Lock-in Option<sup>6</sup>

To capitalize on the opportunity to grow your wealth, from the 15<sup>th</sup> policy anniversary onwards, you may convert a portion of the Terminal bonus into Annual Dividend by exercising the Terminal Bonus Lock-in Option. You may then cash out or leave it to accumulate in the policy<sup>5</sup> to enjoy higher returns. While the policy is in force, up to 60% of the Terminal Bonus may be converted.

By reducing the Sum Insured<sup>7</sup>, you may also withdraw Cash Value, without deduction of any diabetic benefits paid. Alternatively, you may get access to cash by taking out a policy loan of up to 90% of the Guaranteed Cash Value. The remaining value will meanwhile continue to accumulate.

## Flexible Plan Versions and Premium Payment Terms



计划提供两款选择，分别是以人寿保障为主的“特选计划”，以及储蓄成分较高的“特级计划”，让父母灵活地为孩子策划未来。

此外，计划备有 5、10 或 20 年缴付保费年期，您可根据个人需要选择。

Two plan versions are available for you to choose from. Plan Smart provides primary focus on life protection, while Plan Wise focuses more on savings, giving you the flexibility in mapping out the future of your child.

Meanwhile, you may opt for a 5, 10, or 20-year premium-payment term, depending on your personal preference.

## Chronic Disease Management - Coverage for Diabetes



糖尿病是主要慢性疾病之一，目前约有 10% 人口患有糖尿病\*，就此计划特别为合格受保人<sup>8</sup>由65岁的保单周年日开始提供糖尿病保障。

Diabetes is one of the most common chronic diseases. Currently, some 10% of population is suffering from it\*. The plan supports the qualified Insured<sup>8</sup> with diabetic benefits from the policy anniversary following his / her 65<sup>th</sup> birthday.

## 保证可保权益

为配合孩子于人生不同阶段的保障需要，计划更让您于孩子年满 18 岁的保单周年日后，当注册结婚、子女出生或置业后作出物业首按时，可选择投保新一份终身寿险计划或附加定期人寿保障计划，又可增加附加定期人寿保障的保障额，而无须提供任何健康证明文件<sup>11, 12</sup>。

## 失业的特惠宽限期保障

万一保单持有人于保单有效期内不幸遭裁员或遣散，即可享有长达 365 日的“特惠宽限期”，于该期限内孩子仍可继续享有十足的保障<sup>13</sup>。

## 附加保障

此外，您可度身订制配合孩子需要的保障组合，以小额保费享有一系列附加保障：

**自选缴款人保障** – 万一保单持有人于 65 岁的保单周年日前不幸身故或完全伤残并持续达 6 个月以上，我们会代为支付计划的全数保费，直至受保孩子年满 25 岁的保单周年日为止<sup>14</sup>，确保您为孩子筹划的大计可如期实现。

**其他附加保障** – 儿童严重疾病保障、儿童意外保障等。

## Guaranteed Insurability Option

The plan is designed to cater for your child's protection needs in different stages of life. At the policy anniversary following your child's 18<sup>th</sup> birthday, a new whole life plan or term life supplementary benefit can be taken out or the Sum Insured of a term life supplementary benefit can be increased upon registering a marriage, the birth of a child or a first mortgage for a residential property, without any health declaration<sup>11, 12</sup>.

## Special Grace Period for Unemployment

Should the policyowner be made redundant, a special grace period for unemployment will be provided which allows suspension of premium payment for 365 days. During this entire period, your child will remain fully covered by the insurance<sup>13</sup>.

## Supplementary Benefits

You may also tailor a protection portfolio with a full spectrum of supplementary benefits for your child at an additional premium:

**Optional Payor's Benefit** – In the unfortunate event of the policyowner's death or total disability for over 6 consecutive months before the policy anniversary following his / her 65<sup>th</sup> birthday, we will pay all premiums for you until the policy anniversary following the insured child's 25<sup>th</sup> birthday<sup>14</sup>, so that the entire plan for the child can still be achieved.

**Other supplementary benefits** – Critical Illness Benefit and Accident Benefit for children, etc.



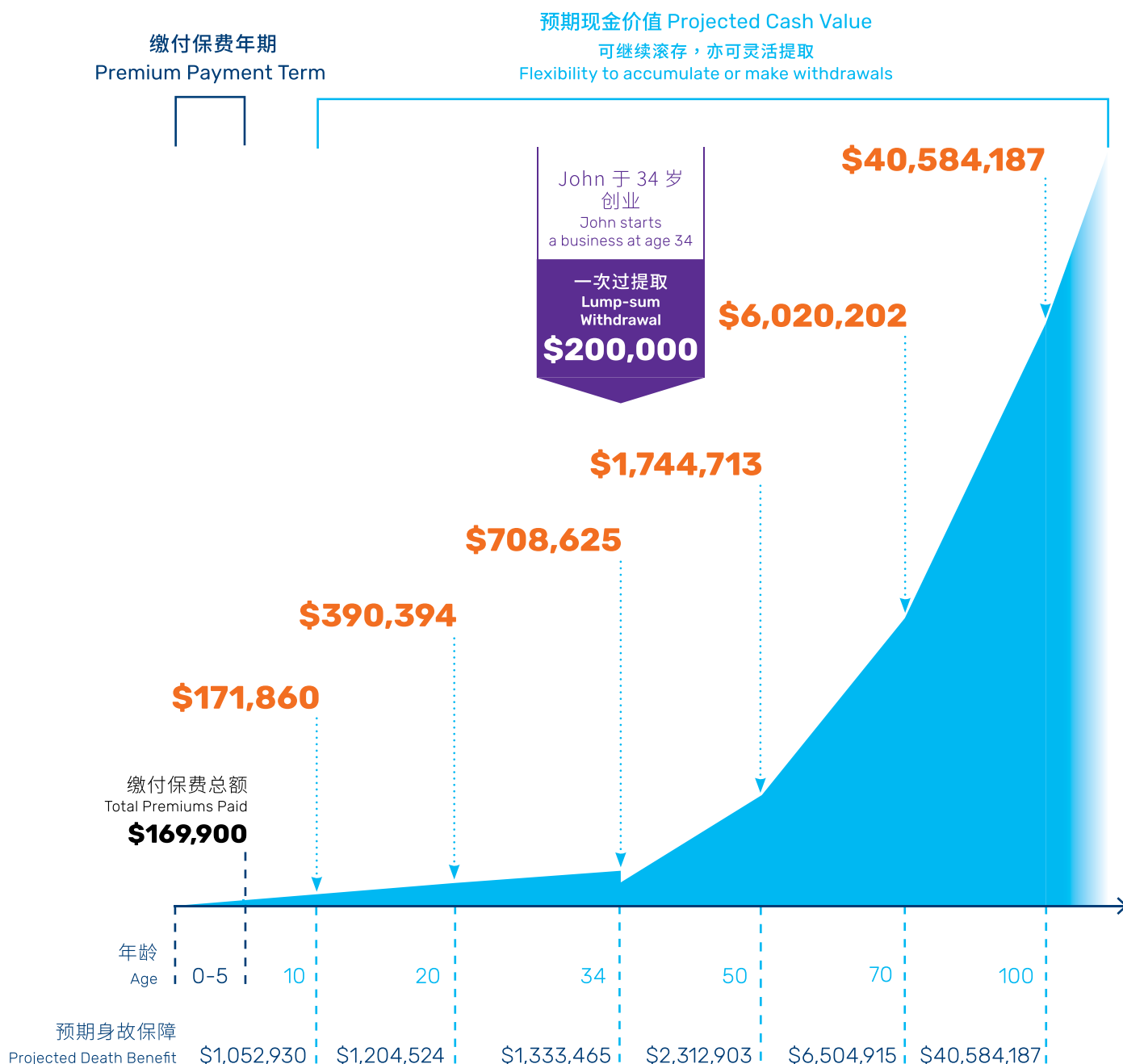
# 为未来需要作储蓄

## Saving up for Future Needs

例子: Mary初为人母, 为了给新生儿子John累积长线财富, 以便更有计划地筹划未来, 她投保尚智未来寿险计划的“特级计划”, 保障额为1,000,000美元, 缴付保费年期为5年, 每年33,980美元, 总保费为169,900美元。

Example: Mary is a first-time mom. For her newborn son, John, to accumulate long-term wealth for better future planning, she takes out a Plan Wise from LifeDeluxe for Future with a Sum Insured of US\$1,000,000 based on an annual premium of US\$ 33,980 and a premium-payment term of 5 years. The total premiums amount to US\$ 169,900.

Remarks: The above example is based on a boy aged 0 who takes out a Plan Wise from LifeDeluxe for Future. The projected Cash Value and Death Benefit are calculated based on the current projected accumulated Annual Dividends and Interest, Terminal Bonus and premium paid annually in full during the premium payment term, and provided that no Terminal Bonus Lock-in Option has been exercised and no policy loan has been made, except the illustrated withdrawal of Cash Value by reducing the Sum Insured, while the policy is in force. The above figures are hypothetical and for reference only, and are rounded to the nearest integer.



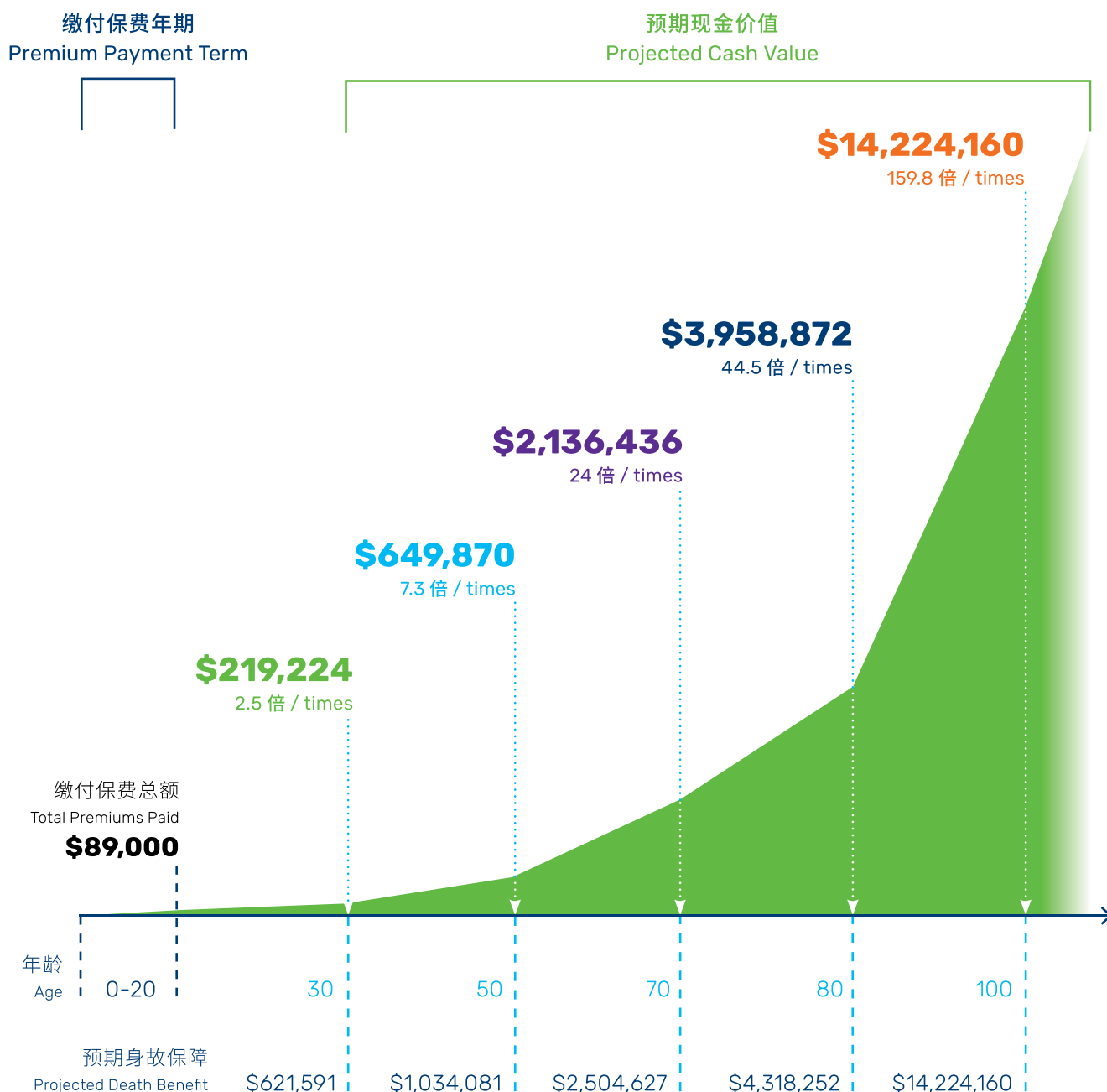
# 一份终身守护的礼物

## A Gift for Lifelong Protection

例子： Tony喜迎一对双胞胎女儿的诞生，为了给她们一个周全的保障，他给她们各人投保一份尚智未来寿险计划的“特选计划”，保障额各为500,000美元，缴付保费年期为20年，每年各4,450美元，总保费各为89,000美元。

Example: Tony is thrilled to have twin daughters. To give them comprehensive protection, he takes out a Plan Smart from LifeDeluxe for Future for each of them, with a Sum Insured of US\$500,000 based on an annual premium of US\$4,450 and a premium-payment term of 20 years. The total premiums amount to US\$89,000 each.

The above figures are hypothetical and for reference only, and are rounded to the nearest integer.

4. 现金价值将根据缴付保费年期、所选的计划版本、保单年期、保单货币、投保年龄等因素而厘定。毋须扣除已支付的糖尿病现金津贴或糖尿病并发症赔偿。
5. 累积年终红利的积存利率并非保证,并按所选择之保单货币而有所不同,并由本公司不时厘定。
6. 于保单生效满 15 年后,每个保单周年日起计的 30 日内,可提出书面要求行使终期红利锁定权益,每次转换的锁定百分比现时最少为 5%及锁定百分比的总和最高为60%。已转换的终期红利将不可被还原。须符合当时的行政规则。
7. 调低保障额会令日后的保证现金价值、年终红利、终期红利按比例相应减少。
8. 适用于以标准保费率发出的保单(即没有额外费用及不保事项的保单)。受保人投保时,须没有患上特定疾病(如糖尿病、癌症等)。
9. 每保单年的糖尿病现金津贴以每名受保人1,250美元 / 10,000港元 / 澳门元为限,而个人于本公司就此保障的最高总赔偿为25,000美元 / 200,000港元 / 澳门元。糖尿病现金津贴及糖尿病并发症赔偿的总额以保障额的20%为限。糖尿病现金津贴将于受保人领取20年后或于其领取糖尿病并发症赔偿时终止。
10. 受保人于65岁的保单周年日起若确诊指定并发症,可获糖尿病并发症赔偿。赔偿仅发放一次,而个人于本公司就此保障的最高总赔偿为62,500美元 / 500,000港元 / 澳门元。糖尿病现金津贴及糖尿病并发症赔偿的总额以保障额的20%为限。当受保人领取糖尿病现金津贴20年后,糖尿病并发症赔偿将会终止。
11. 保证可保权益适用期由受保人 18 岁至 56 岁的保单周年日止。于每次行使权益时,新投保的计划或附加于尚智未来寿险计划的定期人寿保障计划的最高保障额或附加于尚智未来寿险计划的定期人寿保障计划的新增保障额为 50,000 美元 / 400,000 港元 / 澳门元或原来尚智未来寿险计划保障额的50%,以较低者为基准。可供选择的终身寿险计划由本公司指定,而计划中除身故保障外的其他保障或权益可能不适用于新保单。此权益只适用于以标准保费率发出的保单,只可在注册结婚、子女出生、合法领养 18 岁以下子女及置业后作出物业首按的情况下各行使一次,最多行使三次。若受保人曾根据本保单或本公司缮发的其他任何保单或附加保障索偿完全及永久伤残保障、末期病症保障,或任何阶段的严重疾病保障,则不可行使此权益。有关详情及条款,请参阅保单文件。
12. 附加定期人寿保障计划须符合当时的行政规则。
13. 失业的特惠宽限期保障只适用于基本计划。
14. “缴款人保障”将于受保人年满25岁的保单周年日或保单持有人年满65岁的保单周年日终止,以较早的日期为准。

2. Net of policy debt.
3. Net of the total Cash Benefits for Diabetes and the Benefit for Diabetic Complications paid (if applicable).
4. The Cash Value will be determined by the premium payment term, the selected plan version, policy duration, policy currency, issue age, and other factors. No Cash Benefit for Diabetes or Benefit for Diabetic Complications paid will be deducted from the Cash Value.
5. The interest rate for the accumulation of Annual Dividends is not guaranteed and varies according to the policy currency. The rate will be determined by the Company from time to time.
6. After the policy has been in force for 15 years, and within 30 days after each policy anniversary, you may submit a written request to exercise the Terminal Bonus Lock-in Option. The Lock-in Percentage for each conversion cannot be less than 5% and the aggregate Lock-in Percentage cannot exceed 60%. Conversion of the Terminal Bonus cannot be reversed once the lock-in option is exercised, and is subject to prevailing administration rules.
7. Reducing the Sum Insured of the policy will reduce the amount of the Guaranteed Cash Value, Annual Dividend, and Terminal Bonus on a pro-rata basis.
8. Applicable to a standard rate policy (i.e., a policy without any loadings or additional exclusions). The Insured shall not suffer from specified conditions (e.g., diabetes, cancer, etc.) when taking out the policy.
9. The Cash Benefit for Diabetes for each policy year is limited to US\$1,250 / HK\$ / MOP10,000 on a per Insured basis, subject to US\$25,000 / HK\$ / MOP200,000 per life limit under this benefit issued by the Company. The total benefit payments for Cash Benefit for Diabetes and Benefit for Diabetic Complications is limited to 20% of the Sum Insured. The Cash Benefit for Diabetes shall be terminated after 20 years of payments or upon payment of the Benefit for Diabetic Complications.
10. The Insured is entitled to the Benefit for Diabetic Complications when he / she is diagnosed with the designated complications from the policy anniversary following his / her 65<sup>th</sup> birthday. The benefit is payable once only, subject to US\$62,500 / HK\$ / MOP500,000 per life limit under this benefit issued by the Company. The total benefit payments for Cash Benefit for Diabetes and Benefit for Diabetic Complications is limited to 20% of the Sum Insured. The Benefit for Diabetic Complications shall be terminated after 20 years of payments of Cash Benefit for Diabetes.
11. The Guaranteed Insurability Option will be valid from the policy anniversary following the Insured's 18<sup>th</sup> till his / her 56<sup>th</sup> birthday. For each time the Guaranteed Insurability Option is exercised, the maximum Sum Insured of the new policy or term life supplementary benefit attachable to LifeDeluxe for Future or maximum increase amount in Sum Insured of term life supplementary benefit attachable to LifeDeluxe for Future shall be US\$50,000 / HK\$ / MOP400,000 or 50% of the Sum Insured of the original LifeDeluxe for Future, whichever is lower. The whole life plans for selection will be specified by the Company. Any benefits or options other than death benefit may not be provided under the new policies. This Option is applicable to standard rate policy only and can at most be exercised three times and once for each life event (including marriage, giving life to a child, legal adoption of a child under the age of 18 and a first mortgage of a residential property). If the Insured has made claims for benefits for total and permanent disability, terminal illness, or any stage of critical illness under this policy or any other policies and supplementary benefits issued by the Company, this Option cannot be exercised. Please refer to the policy document for the relevant terms and conditions.
12. Term life supplementary benefit is subject to prevailing administrative rules.
13. Special Grace Period for Unemployment is only applicable to the Basic Plan.
14. The "Payor's Benefit" is valid until the policy anniversary following the insured child's 25<sup>th</sup> birthday or the policyowner's 65<sup>th</sup> birthday, whichever is sooner.

## 重要资料

### 红利 / 终期红利理念

公司已成立一个委员会，在厘定年终红利及 / 或终期红利派发之金额时向公司董事会提供独立意见。实际年终红利及 / 或终期红利派发之金额会先由委任精算师建议，然后经此委员会审议决定，最后由公司董事会（包括一个或以上独立非执行董事）批准。

你的保单为分红保险计划并可分享由我们厘定之相关产品组别中的盈余。于厘定年终红利及 / 或终期红利时，我们致力确保保单持有人和本公司能得到合理的盈余分配。此计划的利润与亏损会因包括但不限于投资、索偿及保单续保率而影响你的资产份额。为使我们与你的利益一致，我们的目标是将不少于 90% 的可分配利润分配予你，余下的部分则归于我们。可分配利润和总利润是分开计算且可能不同。

终期红利并不是永久附加于保单。本公司有权决定公布终期红利之频率及金额。我们将最少每年检视及厘定年终红利及 / 或终期红利一次。我们会参考包括但不限于以下因素的过往经验及预期未来展望，以厘定保单的年终红利及 / 或终期红利。

**理赔：**包括产品所提供的身故保障及其他保障的成本。

**投资回报：**包括所投资的资产赚取的利息 / 红利收入及市场价格变动。投资表现会受利息 / 红利收入之波动以及各种市场风险因素如信贷息差、违约风险、股票价格、房地产价格、商品价格之波动、汇率及流动性等而影响。

**退保：**包括保单失效、退保、部分退保及其他扣减项目及保障支付，以及其对投资的相关影响。

为提供更平稳的年终红利及 / 或终期红利，我们或会在投资表现强劲的时期保留回报，用作在投资表现较弱的时期支持或维持较高之年终红利及 / 或终期红利。

年终红利及 / 或终期红利之决定会先由委任精算师建议，然后经由包括一名或以上独立非执行董事的公司董事会批准。

### 投资政策、目标及策略

万通保险国际有限公司（“万通保险”）的投资目标是优化保单持有人的长线回报并维持风险于可接受的水平。资产会被投放于不同类型的投资工具，可能包括环球股票、债券及其他固定收益资产、房地产、商品市场及另类投资等。此多元化之投资组合务求达到可观且稳定的长线投资回报。

我们会根据过往及预期回报、波幅及相关投资风险来选择投资资产及管理我们的投资组合。

为达至长线目标回报，万通保险采用一套以固定收益资产及股票类资产为组合的投资策略。现时的长线投资策略投资在以下资产并按下述比例分配：

资产类别	目标资产组合 (%)
债券及其他固定收益资产	50% – 70%
股票类资产	30% – 50%

债券及其他固定收益资产主要包括拥有高信用评级的政府债券及不同行业的企业债券，提供一个多元化及高质素的债券投资组合。

## Important Information

### Dividend / Terminal Bonus Philosophy

A committee has been set up to provide independent advice on the determination of the Annual Dividend and / or Terminal Bonus amounts to the Board of the Company. The actual Annual Dividends and / or Terminal Bonuses, which are recommended by the Appointed Actuary, will be decided upon the deliberation of the committee and finally approved by the Board of Directors of the Company, including one or more Independent Non-Executive Directors.

Your policy is a participating policy and can share the divisible surplus from the product group determined by us. Annual Dividends and / or Terminal Bonuses will be determined with an aim to ensure fair sharing of profits between policyholders and the Company. In the plan, profit and loss arising from including, but not limited to, investment, claims and policy persistency will impact your asset share. To align our interest with yours, we aim to share with you no less than 90% of the distributable profit while the remaining portion goes to us. The amount of distributable profits is determined separately from and may not be the same as the total profits.

Terminal Bonus does not form a permanent addition to the policy. The Company has the right to determine the declaration frequency and the declared Terminal Bonus amount. The Annual Dividends and / or Terminal Bonuses will be reviewed and determined by us at least once per year. In determining the Annual Dividends and / or Terminal Bonuses, we will take into account both past experience and expected future outlooks for factors including, but not limited to, the following.

**Claims:** These include the costs of providing coverage such as death benefit and other benefits.

**Investment performance:** This includes interest / dividend income and changes in the market value of the invested assets. Investment performance could be affected by fluctuations in interest / dividend income and various market risk factors, such as credit spread, default risk, fluctuations in equity prices, property prices, commodity prices, exchange rates, and liquidity risk, etc.

**Surrenders:** These may include policy lapses, surrenders, partial surrenders and other deductions and benefit payments; and the corresponding impact on investments.

To provide more stable Annual Dividends and / or Terminal Bonuses, we may retain returns during periods of strong performance to support or maintain stronger Annual Dividends and / or Terminal Bonuses during periods of less favourable performance.

The determination of Annual Dividends and / or Terminal Bonuses will be recommended by the Appointed Actuary and approved by the Board of Directors of the Company, including one or more Independent Non-Executive Directors.

### Investment Policy, Objective and Strategy

Past and expected future performance, volatility, and the associated risks of investment assets are considered in selecting investment assets and managing our investment portfolio.

To achieve the long-term target returns, YF Life Insurance International Ltd. implements a strategy utilizing a mix of fixed-income and equity-like investments. The current long-term target strategy is to allocate assets as follows:

Equity-like assets	30% – 50%

Bonds and other fixed-income investments mainly include high credit rating government bonds and corporate bonds across a variety of industries, making up a diversified bond portfolio with high asset quality.
