

## **YFLink Concert Tickets Lucky Draw (Hong Kong) Terms and Conditions ("Terms and Conditions")**

#### **Personal Data Collection Statement (Hong Kong)**

**YF Life Insurance International Ltd.** (the “**Company**” or “**YF Life**”) respects personal data privacy and is committed to complying with the **Personal Data (Privacy) Ordinance** (Cap. 486) and the Data Protection Principles thereunder. This statement explains

the **purposes, uses, disclosure/transfer, retention/security**, and the **rights of access and correction** in relation to personal data collected from participants of this lucky draw (the “**Lucky Draw**”).

### 1) Purposes and Uses

YF Life will collect, use, and retain participants’ personal data solely for the following purposes (and any **directly related purposes** thereto):
