
IMPORTANT NOTES

- 1 The MASS Mandatory Provident Fund Scheme ("Scheme") is a mandatory provident fund scheme.

The guarantee will only be provided by YF Life Insurance International Ltd. if and when a scheme member withdraws accrued benefits as a result of any one of the following qualifying events: a) attainment of normal retirement age; b) attainment of early retirement age; c) death or d) total incapacity. The MPF Conservative Fund under the Scheme uses method (i) and, therefore, the unit prices/ net asset value/ fund performance quoted have incorporated the impact of fees and charges.
