Thank you for your continued support for the Scheme. We are writing to inform you of the following changes to the Scheme. All the following changes will not have any adverse impact on members.

1. Change of the address of the Trustee and the insurer of MASS MPF Guaranteed Policy (“Policy”), the underlying APIF Policy of the Guaranteed Fund

With effect from November 21, 2016, the address of the Trustee and the insurer of the Policy will be changed as follows:
