New Investment Choices and Change of the Dividend Policy of the Scheme

With effective from 28 July 2021, the following new investment choices will be available under the Scheme:

As the new investment choices #1-9 are investment choices that you may elect to receive dividends of the underlying funds in cash, the policy provision of the Scheme will be revised with effect from 28 July 2021 as follows:

- (a) The following definition shall be added after the definition "Investment Choices." in the "INVESTMENT CHOICE PROVISIONS".
 - "Investment Choices (Cash Distribution). You may elect to receive dividends of the underlying funds of some of the Investment Choices in cash. These Investment Choices are called Investment Choices (Cash Distribution)."
- (b) The section "Dividend of Underlying Fund." in the "INVESTMENT CHOICE PROVISIONS" shall be replaced with the following paragraphs.

"Dividend of Underlying Fund. In the event that dividend is to be paid under any underlying fund, the dividend will be distributed by us through (1) re-investing the dividend to purchase Units of the Investment Choice of the said underlying fund as default or (2) paying out the dividend in cash for Investment Choice (Cash Distribution) if elected by you as the distribution method. We reserve the right to change the distribution method, subject to prior notification, of any Dividend of Underlying Fund.

- (1) Re-investment of dividend to purchase Units of the Investment Choice of the said underlying fund (default option)
 Dividend will be used to purchase Units of the Investment Choice of the said underlying fund at Offer Price. Units are
 purchased subject to any subscription limitations imposed by the said underlying fund and will be credited to the
 Policy Value. In case there is any outstanding dividend not used to purchase Units due to subscription limitations, the
 outstanding dividend will be carried forward and Units will be purchased on the next valuation day of the Investment
 Choice, subject to the same limitations imposed by the said underlying fund. No interest will be credited on any
 unallocated money.
- (2) Paying out dividend in cash (for Investment Choice (Cash Distribution) only)

 For Investment Choices (Cash Distribution), you will receive the dividend of the underlying funds in cash if elected by you as the distribution method."

The amendment to the policy provision of the Scheme will neither result in any changes to the features of the Scheme nor have adverse impact to the policyholders. The endorsement to the policy provision is enclosed for your record.

The Investment Choice Brochure of the Scheme will also be updated to include the information of new investment choices and the risks associated with Investment Choice (Cash Distribution) and the distribution arrangement for Investment Choice (Cash Distribution).
