With reference to the “Notification for Change of Investment Choice” dated 10 March 2022 and 25 May 2022 respectively about the suspension of dealing of the Investment Choices, we would like to inform you that the suspension of the dealing and calculation of net asset value of the underlying funds is still continued until further notice.

Actions to be taken

(i) Policies with existing regular premium allocation to the Investment Choices

You may redirect your existing regular premium allocation to other investment choice(s) available under the Schemes free of charge by submitting a reallocation instruction to us. You can submit such request online through the e-Policy Service at our company website (www.yflife.com) or the mobile application YFLink. Alternatively, you can make the request by using the “Request for Change of Policy Value/Account Value Arrangement Form” which can be obtained from your Consultant or our Customer Service Hotline.

(ii) Policies with existing notional units in the Investment Choices

Your existing notional units remain in your policy. Any instruction of redemption and switch-out of the Investment Choices cannot be processed at the moment until the resumption of the dealing and valuation of the underlying Funds.

(iii) Policies with instruction submitted for valuation date on or after the Effective Date

Your instruction of subscription, redemption or switching of notional units of the Investment Choices will be held until the dealing and valuation of the underlying funds resume.
