

## Name change of investment expert, investment managers and investment funds

# 1) Schroder Investment Management (Hong Kong) Limited

With effect from 2<sup>nd</sup> April 2008, the Chinese company name of Schroder Investment Management (Hong Kong) Limited will be changed from "寶源投資管理(香港)有限公司" to "施羅德投資管理(香港)有限公司" while the English company name will remain unchanged. The Chinese name of the underlying funds managed by Schroder Investment Management (Hong Kong) Limited will also be changed accordingly. In respect of the above, the Chinese name of the investment expert and the investment manager of the underlying funds and the Chinese fund names of the following investment funds will be changed accordingly:
