The following change(s) of investment fund(s) is/are relating to the “Premier-Choice Series” plans including Premier-Choice Flexi, Premier-Choice Flexi Plus, Premier-Choice InvestPlan and Premier-Choice Plus InvestPlan.

**1) Change of names of investment funds**

With effect from 30 September 2008, the name of CitiSelect Asia Tilt Series will be renamed to “Legg Mason Asia Tilt Series”. Accordingly, the names of the following investment funds will be changed:

**2) Change of investment manager**

With effect from 30 September 2008, the investment manager of underlying funds of the following investment funds will be changed. Notwithstanding, there will be no change to the fees and the investment objective and strategy of the underlying funds.

**3) Change of investment objective and strategy**

With effect from 26 September 2008, the investment strategy of underlying funds of ABN AMRO Funds – Global Emerging Markets Bond Fund Class “A” (ABEMU) will be changed to enable the underlying fund to use extensively financial derivative instruments for hedging, efficient portfolio management and investment purposes.

**4) Minor matters relating to some other investment funds**

With effect from 1 August 2008, the management company of underlying funds managed by ABN AMRO Asset Management had been changed.

This minor matter has no impact to the investment objective and strategy and fund charges of the investment funds in the “Investment Choice” brochure.

**NOTICE TO THE HONG KONG UNITHOLDERS OF

Dear Unitholder,

In our capacity as management company of CitiSelect Portfolios (the "Fund"), we would like to inform you that subject to regulatory approval, as from 30 September 2008 (the "Effective Date"), the name of the Fund will be changed and Smith Barney Fund Management LLC will no longer serve as General Portfolio Manager and Investment Adviser to the Fund.

**1. Change of Name**

As from the Effective Date, the name of the Fund will change to "Legg Mason Portfolios".

The Sub-Funds of CitiSelect Global Series and CitiSelect Asia Tilt Series will be renamed "Legg Mason Global Series" and "Legg Mason Asia Tilt Series" respectively.

Further to the above changes, it was decided to amend the names of the Sub-Funds as follows:

- CitiSelect Portfolios CitiSelect Global Balanced will be renamed Legg Mason Portfolios - Legg Mason Global Balanced Portfolio;
- CitiSelect Portfolios CitiSelect Global Growth will be renamed Legg Mason Portfolios - Legg Mason Global Growth Portfolio;
- CitiSelect Portfolios CitiSelect Global Enhanced Growth will be renamed Legg Mason Portfolios - Legg Mason Global Enhanced Growth Portfolio;
- CitiSelect Portfolios CitiSelect Asia Tilt Balanced will be renamed Legg Mason Portfolios - Legg Mason Asia Tilt Balanced Portfolio;
- CitiSelect Portfolios CitiSelect Asia Tilt Growth will be renamed Legg Mason Portfolios - Legg Mason Asia Tilt Growth Portfolio; and
- CitiSelect Portfolios CitiSelect Asia Tilt Enhanced Growth will be renamed Legg Mason Portfolios - Legg Mason Asia Tilt Enhanced Growth Portfolio.

**2. Change of General Portfolio Manager and Investment Adviser**

As from the Effective Date, Smith Barney Fund Management LLC will no longer serve as General Portfolio Manager and Investment Adviser to the Fund. Legg Mason Global Asset Allocation, LLC will be appointed General Portfolio Management and ClearBridge Advisors, LLC will be appointed as one of the Investment Advisers.

The new General Portfolio Manager and Investment Adviser are incorporated in the United States and are regulated by the United States Securities and Exchange Commission. They are companies belonging to the same group as Smith Barney Fund Management LLC.

A new Hong Kong Summary Prospectus will be issued to reflect the above as well as other minor changes more fully reflected in the documents available at the registered office of the Hong Kong Representative of the Fund.

Unitholders may inspect, and obtain free of charge, the Hong Kong Summary Prospectus during business hours at the registered office of the Hong Kong Representative of the Fund at 12/F., York House, The Landmark, 15 Queen's Road Central, Hong Kong (Investor Hotline : (852) 3652 3088).

Capitalised terms used in this notice and not otherwise defined shall have the meaning as set forth in the new Hong Kong Summary Prospectus.

The directors of the Management Company accept responsibility for the accuracy of the information contained in this notice.

The changes mentioned above will have no effect on the portfolios of the Sub-Funds, on the manner in which the Sub-Funds will be managed or on the fee structure of the Sub-Funds.
