**1. Change of Management Company – Fortis L Fund**

(Fortis L Fund - Equity Brazil "Classic-Capitalisation" (FLBEU), Fortis L Fund - Bond Best Selection World Emerging "Classic-Capitalisation" (FLEMU), MassMutual Fortis L Fund - Equity Russia "Classic-Capitalisation" (FLREU) and MassMutual Fortis L Fund - Equity Utilities World "Classic-Capitalisation" (FLUTU))

Fortis Investment Management Luxembourg S.A., will have 100% of its shareholdings acquired by BNP Paribas Asset Management Luxembourg S.A. Thereafter, Fortis Investment Management Luxembourg S.A. will be absorbed on June 30, 2010 by BNP Paribas Asset Management Luxembourg S.A. As a result of the above mentioned merger, BNP Paribas Investment Partners Luxembourg will legally replace Fortis Investment Management Luxembourg S.A. as the Management Company of FORTIS L FUND, with effect from June 30, 2010.

The change of Management Company will be made free of charge.

**2. Minor matters relating to Parvest’s update**

Upon BNP Paribas Investment Partners SA acquiring the entire shareholding of Fortis Investment Management SA, and as part of the integration of their subsidiary asset management companies in Hong Kong, the business of BNP Paribas Asset Management Asia Limited will be transferred to BNP Paribas Investment Partners Asia Limited (the local Fortis Investments entity). As a result of this integration, there will be changes in the Hong Kong Representative of PARVEST and the sub-manager of the underlying fund. Details of these changes are as follows:-

Change to the Hong Kong Representative of Parvest

The Hong Kong Representative, BNP Paribas Asset Management Asia Limited, will be replaced by BNP Paribas Investment Partners Asia Limited.

Notwithstanding the appointment of the new Hong Kong Representative, there will be no change in the fees payable by Parvest.

Change to the sub-manager of the underlying fund

The sub-manager of underlying fund of “Parvest Asian Convertible Bond “Classic” Shares”, BNP Paribas Asset Management Asia Limited, will be replaced by BNP Paribas Investment Partners Asia Limited.

It should be noted that notwithstanding the change in sub-manager, the investment objective, investment policy and operation of the underlying fund will remain unchanged. Also, there will be no change to the fee structure and fee level of the underlying fund.
