The Directors of the Company wish to announce that all of the resolutions detailed in the Notice of Annual General Meeting sent to the shareholders on 25 June 2007 and detailed in a circular sent to shareholders on 25 June 2007, were passed at the Annual General Meeting held on 22 August 2007. In particular, the Articles of Association of the Company are amended :

- 1. to provide for segregated liability between the sub-funds of the Company;
- 2. to allow the Net Asset Value per Share for each Share Class of the Funds to be calculated and expressed to up to three decimal places;
- 3. in relation to valuation of over-the-counter derivatives to provide that these derivatives "shall be valued in accordance with the guidelines of the Financial Regulator"; and
- 4. to add to the lists of regulated markets, stock exchanges and financial derivatives markets in which the Funds' investments may be made.
