Consequently Natwest will be appointed as trustee of the underlying fund of BAEUU on January 16, 2012.

As trustee, Natwest will have the same duties and responsibilities as RBS and the change of trustee will have no impact on the level of fees borne by the underlying fund or on the way the underlying fund is operated.

The above minor matter has no impact to the investment objective and strategy of the relevant investment choice.
